Taxes on cross-border transactions is a matter that tax barristers can accept instructions in. Barristers specialising in tax are not obliged to take direct briefs, but many do. Barristers may directly give legal advice and may prepare and advise on certain legal documents (in addition to their dispute related work). Fees for barristers are based upon the complexity and likely timeframe that a matter will take. These will be discussed with in advance so that there is total transparency at all stages. A tax barrister can advise on pension disputes and appeals concerning access to ill-health retirement benefits. Seasoned tax experts could advise on the amounts of tax due to HMRC. Disclosure of tax affairs are an area of HMRC tax investigations that tax barristers can assist with.



The services of a barrister with a tax specialism can include expert advocacy at all Tax Tribunal and Court hearings UK tax law can be complex and, to some, a little daunting. A tax advisor's dealings with a company looking to merge with or acquire another company may vary from their professional relationship with an estate executor seeking to minimize estate taxes. Should there be a dispute between HMRC and a taxpayer, a tax barrister will have significant experience in managing and litigating tax appeals and can provide strategic, technical and procedural

Tax Disputes

Some tax policy is based on inadequate information about cost, both the administrative cost to the business and the full cost to the economy. Exploitation of intellectual property rights is a matter which an skilled tax barrister may advise upon. If you need someone to have conduct of your case and be responsible for corresponding with the court and other parties, you will either need to instruct a solicitor or a barrister who can conduct litigation. Instructing a solicitor who, in turn, instructs a barrister, is the traditional route. If you cannot afford a barrister Legal aid means that the government will help you to meet the costs of legal advice and/or representation in a court or tribunal. your case is eligible for legal aid; the problem is serious; and. you cannot afford to pay for legal costs. Activities that tax barristers engage in include ascertaining all the relevant facts and advising on the merits at the outset and drafting robust letters to HMRC. Barristers are regulated specialist legal advisers and court room advocates. Tax barristers can advise and represent both taxpayers and tax authorities, including HMRC. A tax dispute expert will act on disputes and disclosures relating to a broad range of taxes, from VAT and stamp duty land tax to remuneration and termination packages, including IR35 issues, as well as income tax, capital gains tax, inheritance tax and the annual tax on enveloped dwellings. Tax barristers work with large-scale corporate litigation in the higher courts to advisory work on complex personal tax planning. Members of chambers regularly receive instructions from solicitors and accountancy firms of all sizes (from the Magic Circle solicitors and the Big Four accountants to high street advisors), trust companies and directly from in-house professionals from a wide variety of industries. Online Hearings

The area of law a barrister practices in will dictate to a certain extent the type of work they undertake and the amount of time they spend in court. Criminal barristers, for example, will carry out much of their practice in court acting for the prosecution or defending a client. Tax law can make a real difference—and we're not just talking about saving a few pounds on a tax return. Taxes can be confusing at times, and the guidance of a tax barrister can help keep businesses afloat or a family's finances intact. Some pensions law experts have over 15 years' experience

advising on pensions law and regulation. It is my belief that tax is a fundamental mechanism used to reconcile society's conflicting economic goals and needs, because the way in which tax is collected does, in my opinion, both reflect and shape the society that charges it. The responsibilities of a barrister will vary depending on the area that they specialise in and where they practice. For example a barrister specialising in criminal law is likely to spend a lot more time in court than a barrister specialising in chancery law.
